Payments to City Hall

The forms of payments to the City of Vinita Park must be cash, money orders, or a business check.

No personal checks will be accepted for payment.

Code Adoption

Ordinance No. 1247, Adoption of the National Electrical Code/2008, NFPA 70 and Ordinance No.1248, Adoption of the International Code Council (ICC) Codes were passed at the March 16, 2015 Board Meeting. The following code books will be on file at the City Hall for public to view: 2009 ICC Code Book and 2008 National Electrical Code Book (NEC).

BASIC EMERGENCY SUPPLY KIT

A basic emergency supply kit could include the following recommended items:

- Water, one gallon of water per person per day for at least three days, for drinking and sanitation
- Food, at least a three-day supply of non-perishable food
- Battery-powered or hand crank radio and a NOAA Weather Radio with tone alert and extra batteries for both
- Flashlight and extra batteries
- First aid kit
- Whistle to signal for help
- Dust mask to help filter contaminated air and plastic sheeting and duct tape to shelter-in-place
- Moist towelettes, garbage bags and plastic ties for personal sanitation

- Wrench or pliers to turn off utilities
- Manual can opener for food
- Local maps
- Cell phone with chargers, inverter or solar charger

Once you have gathered the supplies for a basic emergency kit, you may want to consider adding the following items:

- Prescription medications and glasses
- Infant formula and diapers
- Pet food and extra water for your pet
- Cash or traveler's checks and change
- Important family documents such as copies of insurance policies, identification and bank account records in a waterproof, portable container. You can use the Emergency Financial First Aid Kit
 EFFAK (PDF - 977Kb) developed by Operation Hope, FEMA and Citizen Corps to help you organize your information.
- Emergency reference material such as a first aid book or free information from this web site. (See Publications)
- Sleeping bag or warm blanket for each person. Consider additional bedding if you live in a coldweather climate.
- Complete change of clothing including a long sleeved shirt, long pants and sturdy shoes.
 Consider additional clothing if you live in a cold-weather climate.
- Household chlorine bleach and medicine dropper – When diluted, nine parts water to one part

- bleach, bleach can be used as a disinfectant. Or in an emergency, you can use it to treat water by using 16 drops of regular house hold liquid bleach per gallon of water. Do not use scented, color safe or bleaches with added cleaners.
- Fire extinguisher
- Matches in a waterproof container
- Feminine supplies and personal hygiene items
- Mess kits, paper cups, plates, paper towels and plastic utensils
- Paper and pencil
- Books, games, puzzles or other activities for children

Another informative Town Hall meeting will be held on November 2, 2015. We will provide an overview of the topics from the first Town Hall meeting for those of you that were unable to attend on September 17th.

Dear Residents, did you see the editorial in the Post- Dispatch subject (Building a New St. Louis, Starting over to make the City great again. This is the latest example of the political campaign being waged against municipalities in St. Louis County. Political organizations such as Better Together and Arch City Defenders have taken last year's tragedy in Ferguson and subsequent events in the surrounding communities to further their political agenda; forced consolidation and elimination of the municipal structure of St. Louis County and ultimately the merger St. Louis City and St. Louis County.

Built on deep pocket campaign contributions in a major part by Rex Sinquefield, these organizations used their political influence to shape Senate Bill 5 so that it would primarily impact municipalities in St. Louis County. The communities hit the hardest are primarily our smaller, African American communities in North St. Louis County.

How do you force consolidation or disincorporation? Take away a community's financial ability to provide services to

their residents by increasing their cost of operation while at the same time taking away revenue. Senate Bill 5 is an unfunded mandate; it requires only St. Louis County municipal police departments to be certified while at the same time limiting municipal general revenue from traffic tickets to 12.5%. In outstate Missouri municipalities the percentage is 20% of general revenue and their police departments are not required to be certified.

Why did Ach City Defenders help draft this legislation that will ultimately cause the consolidation or elimination of our African American communities? Today, more so than ever, we need to be supportive of our smaller communities and the African American leaders.

We, the St. Louis County Municipal League, need to work together to maintain and retain local control. We need to support all our members, especially those that are most affected by Senate Bill 5. There does need to be some change, which is why the League adopted 10 Best Practices over 3 years ago. The League Executive Board, staff and I are here to help. We need to be unified in our campaign to modify Senate Bill 5 so that it doesn't create a financial hardship for the municipalities, is applied evenly throughout the state and is clarified as to how to implement and administer the new regulations

One of my classes, "Mack's Creek", it discussed Senate Bill 5 (SB5), Courts Procedures, Ticketing Racial Profiling, and Revenue. The House Bills 517 & 754 discussed sales tax, back to school, holiday changes for calculators and computers.

Here are some of the laws:

Minor Traffic Violations-not speeding by more than 19mph over the limit or in construction or school zone.

Minor Traffic Violations- fine and cost cannot exceed \$300.00

Some of these new laws will become effective in January 1, 2016 20% of general operating revenue and 12.5% in St. Louis County.
