I would like to send a "special thanks" to Alderman Stokes, for chairing our board meeting February 17, 2015. Alderman Stokes did a fantastic job in running the meeting.

I was in Jefferson City on February 17th and 18th in reference to Senate Bill 5. This bill has passed out of the committee that proposes to change the current 30 percent cap on the revenue a municipality can collect and keep as a percentage of total operating revenue (Mack's Creek Law). The proposal change will reduce the allowable percent to 10 percent. Such a dramatic change would place a financial burden on the municipalities in which we live. Vinita Park residents should not have to pay more taxes to continue to receive the services to which they have become accustomed to, but that will happen if Senate Bill 5 passes in its current form in the house. I don't think it is necessary, or fair. to our police, who work hard every day to protect our residents and businesses from those people that speed, or run red lights and stop signs or otherwise drive irresponsible which puts our family lives and property in danger. Police also respond quickly when we call, they also patrol our streets regularly, which could change if this law passage forces personnel cuts.

Why not enforce the current law after the state guidelines for the percentage calculation or shared with our City Hall staff. To my understanding, such guidelines have still not been drafted by the state auditor's office, but municipalities are still expected to comply with the law. Local Mayors are going to Jefferson City twice a week for the Senate Bill 5 hearing and sharing the reason why this bill is detrimental to our local municipalities and our quality of life.

As elected officials, it is our job to ensure delivery of good services to our residents. Those services include things such as snow/ice removal. street and sidewalk maintenance, building property code enforcement to keep our neighborhood a desirable place to live, police protection, and much more. It costs money to provide these services and we need the legally collected revenue, including reasonable traffic fines earned by those who violate our laws to continue those services. Senate Bill 72 will dissolve all villages in the St. Louis County area, compromising villages may not be incorporated or annexed.

We ask that you continue to work together to make Vinita Park a strong community by engaging our families and successful children.

# Rate Increase Notice Effective February 1, 2015

Residential/Commercial Inspection & Occupancy permits

- One hundred dollars (\$100) for the initial residential inspection
- One hundred twenty five dollars (\$125) for the initial commercial inspection
- No charge for the first residential or commercial re-inspection
- Seventy-five dollars (\$75) for the 2nd re-inspection of the same residential or commercial property, including fire marshal's re-inspection
- Fifty dollars (\$50) for fire inspection for each new commercial occupancy inspection
- <u>Fifty dollars (\$50)</u> for the occupancy permit sale property
- Forty dollars (\$40) for the occupancy permit for residential rental property
- <u>Fifty dollars (\$50)</u> for commercial occupancy permit
- <u>Fifteen dollars (\$15)</u> for a copy of any type of occupancy permit
- <u>Fifty dollars (\$50)</u> for an amended copy of any type of occupancy permit

### Park Reservations

- Thirty dollars (\$30) reservation fee for residents of Vinita Park; plus one hundred dollars (\$100) refundable deposit
- <u>Seventy-five (\$75)</u> reservation fee for non-residents of Vinita Park; plus one hundred dollars (\$100) refundable deposit

## Pet Tags

· Ten (\$10)

# Occupancy Inspection and Permit Required

It shall be unlawful for any person or family to occupy or for any owner or agent to permit the occupant of any building or dwelling of a unit, until the inspection is complete and an occupancy permit has been issued.

The occupancy permit shall not be issued until all violations on the property have been brought into compliance.

#### Street Sweeper

The street sweeper will operate from April 1st through December 1st.

### **Trash Containers**

Please remember to remove your trash/ recycle/yard waste containers from the curb the same day service is rendered to avoid receiving a citation.

The forms of payments to the City of Vinita Park must be cash, money orders or a business check. We apologize for any inconvenience; however, personal checks cannot be accepted.

### **BASIC EMERGENCY SUPPLY KIT**

Once you have gathered the supplies for a basic emergency kit, you may want to consider adding the following:

- · Infant formula and diapers
- · Pet food and extra water for your pet
- · Cash or traveler's checks and change
- · Important family documents such as copies of insurance policies, identification and bank account records in a waterproof, portable container. You can use the Emergency Financial First Aid- EFFAK (PDF - 997Kb) developed should include: by operation Hope, FEMA and Citizen Corps to help you organize your information
- Emergency material such as, a first aid book or free information from the web site (See Publications)
- · Sleeping bag or warm blanket for each

- person. Consider additional bedding if you live in a cold weather climate
- Complete change of clothing including a long sleeved shirt, long pants and sturdy shoes. Consider additional clothing if you live in cold-weather climate Household chlorine bleach and medicine dropper- when diluted, nine parts water to one part bleach, bleach can be used as a disinfectant. Or in an emergency, you can use it to treat water
- · by using 16 drops of regular household liquid bleach per gallon of water. Do not use scented, color safe or bleaches with added cleaners
- Fire extinguisher
- · Feminine supplies and personal hygiene items
- towels and plastic utensils
- · Paper and pencils
- · Books, games, puzzles, or other activities for children

Be prepared for an emergency by keeping your gas tank full and if you find yourself stranded, be safe and stay in your car, put on your flashers, call for help and wait until it arrives.

### HOME

Your disaster supply kit should contain essential food, water, and supplies for at least three days. Keep this kit in a designated place and have it ready in case you have to leave your home quickly. Make sure all family members know where the kit is kept. Additionally, you may want to consider having supplies for sheltering for up to two weeks.

## **Kit Storage Locations**

Since you do not know where you will be when an emergency occurs, prepare supplies for home, work and vehicles.

#### **VEHICLE**

In case you are stranded, keep a kit of emergency supplies in your car. This kit

- Jumper cables
- · Flashlights and extra batteries
- · First aid kits and necessary medications in case you are away from home for a prolonged time

- · Food items containing protein such as nuts and energy bars; canned fruit and portable can opener
- · Water for each person and pet in your car
- AM/FM radio to listen to traffic reports and emergency messages
- · Cat litter or sand for better tire rotation
- · Shovel/Ice scraper
- Warm clothes, gloves, hats, sturdy boots, jackets, and an extra change of clothes
- · Blankets or sleeping bags

#### Also consider

- · A fully-charged cell phone and phone charger
- · Flares or reflective triangle
- Baby formula and diapers if you have a small child
